# RadiciGroup

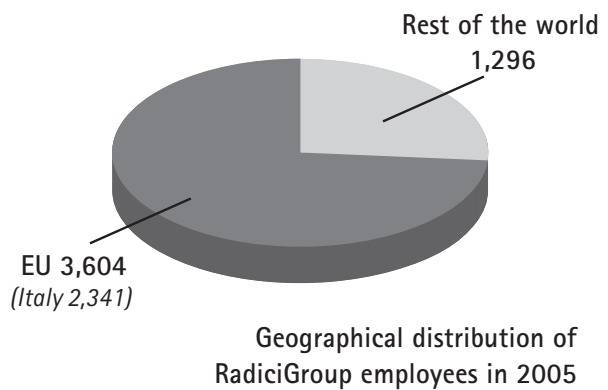
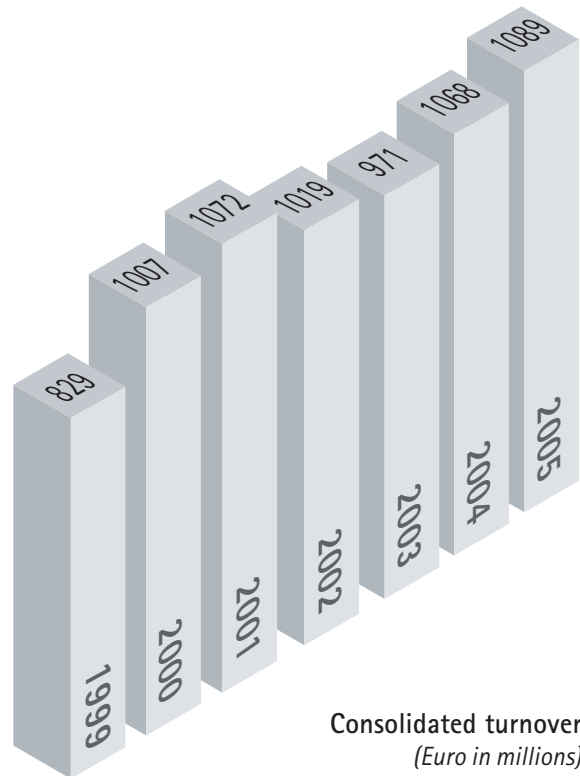

RadiciGroup's strategy for development is guided by the development of its human resources.

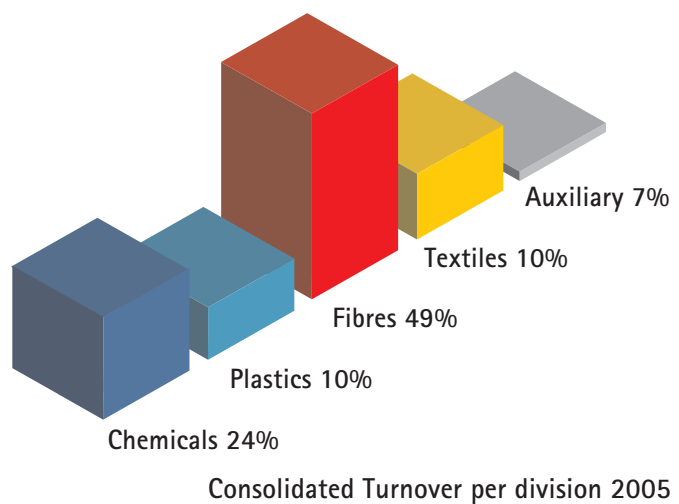

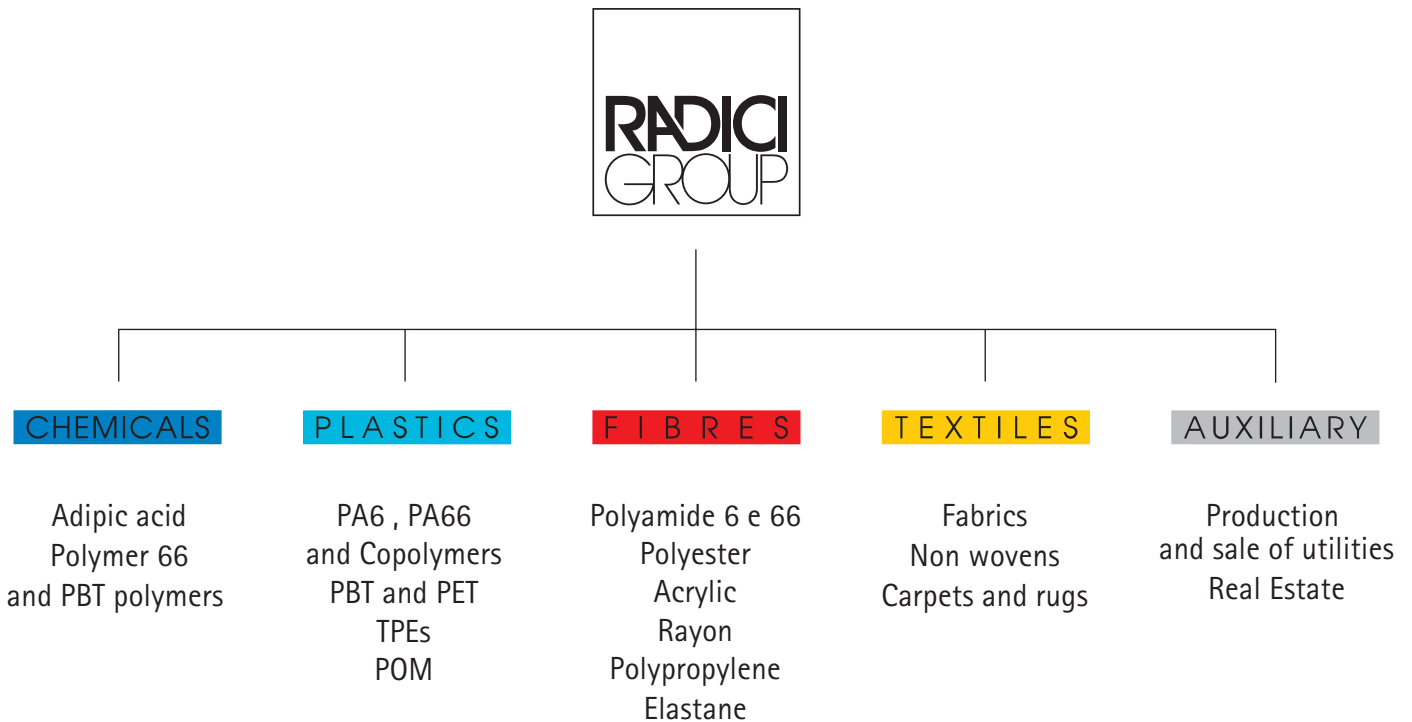


## RadiciGroup's areas of activity
